Aspen View presented a Rural Communities, Rural Schools Sustainability Through Partnerships presentation.

Highlights were as follows:

- Education funding is primarily based on per student funding. This formula inaccurately assumes the cost of providing education rises and falls in lockstep with fluctuations in enrollment. School jurisdictions with declining enrollments (typically rural divisions) experience funding reductions that far exceed their ability to reasonably reduce expenses.
- The three areas of funding include instruction, operation and maintenance and transportation and all are based on per student.
- 2018/2019 projected decrease of 80 Students actual increase of 10 students.
- There is an increase in Boyle School enrollment
- The New Edwin Parr Composite School opened August 2018
- New partnership agreement with Athabasca University and Northern Lakes College. Northern Lakes College has moved into the Athabasca University.
- Continued dual credit program partnership with Portage College
- Aspen View Public Schools is advocating for the replacement of H.A Kostash School (Smoky Lake)
- Communities need to work together to promote Rural Alberta through human resources collaboration and political advocacy.
- AVPS is Advocating for predictable funding over 3-year period
