D. 1) (c) Municipal Services – Wastewater services are provided independently by both municipalities, though Athabasca County does have access and use of the Boyle sewage lagoon through a 2003 MOU. The County further agrees to apply dust control to the road leading to the lagoon (Market Road) annually, at a subsidized rate for the Village of Boyle, and that the work be done at the same time as other local County applications.

D. 2) (o) Municipal Services - Medical Professional Recruitment is a cost-shared initiative between the two municipalities. Athabasca County contributes a maximum of \$10,000 per year to medical professional recruitment for the Village of Boyle.
