

**VILLAGE OF BOYLE  
BYLAW # 05-12**

**THE PURPOSE OF THIS BYLAW IS TO PERMIT TAXPAYERS IN THE VILLAGE OF BOYLE TO PAY PROPERTY TAXES BY MONTHLY INSTALLMENTS.**

**WHEREAS**, Section 340 of the Municipal Government Act, as amended provides that Council may by bylaw, permit taxes to be paid by installments, at the option of the taxpayer, and

**WHEREAS**, it is deemed desirable and in the best interests of the Municipality that a bylaw be passed to permit tax payments by monthly installments.

**NOW THEREFORE**, pursuant to the provisions of the Municipal Government Act, Statutes of Alberta, the Council of the Village of Boyle, duly assembled, enacts as follows:

**1. DEFINITIONS:**

- a) **“Village”** now means the Village of Boyle.
  - b) **“Taxes”** means all taxes levied by the Village and without in any way restricting the generality of the forgoing, shall include property taxes, frontage taxes and local improvement taxes.
  - c) **“Taxpayer”** means a person liable to pay taxes to the Village of Boyle.
2. The taxpayer may elect to pay on a monthly installment basis by signing an agreement with the Village of Boyle.
  3. The monthly installment Agreement will include monthly payments due and payable on the 28th day of each month and these payments that result in the tax account being paid in full December 31<sup>st</sup> of the tax year and shall not be subject to any tax penalties or discounts except as otherwise stated in this bylaw. When the 28th of the month falls on a Saturday, Sunday or General Holiday payment will be accepted the next business day.
  4. The monthly installments shall be calculated in equal amounts from the date of the signing of the Agreement.
  5. A taxpayer who elects to pay taxes on a monthly installment basis shall have all previous years taxes paid prior to signing the Monthly Tax Installment Agreement unless other arrangements have been authorized by Council or the Chief Administrative Officer.
  6. In the event that any taxes remain unpaid on the last day of December of the year for which they were levied then all taxes owing shall be subject to the tax penalty bylaw of the Village of Boyle.
  7. A copy of the Monthly Tax Installment Agreement is attached to and forms part of this bylaw.
  8. **THAT** Bylaw # 01-12 is hereby rescinded upon third and final reading of this bylaw.
  9. **THAT** this bylaw comes into force on the day it is passed.
